<b>Appeals for normal round of admissions</b>	
<i>Please note that current government legislation requires all appeals up to 30<sup>th</sup> September 2021 to be heard by video conferencing.</i>	
<b>Date of allocation of places</b>	1 <sup>st</sup> March 2021
<b>Deadline for lodging appeals and providing evidence to support the appeal (if appropriate)</b>	29 <sup>th</sup> March 2021
<b>Appeals will be heard by</b>	5 <sup>th</sup> May 2021
<b>Notice of appeal hearing</b>	20 <sup>th</sup> April 2021
<b>Deadline for governing body to submit evidence for the appeal</b>	20 <sup>th</sup> April 2021
<b>Deadline for sending appeal papers to all parties</b>	20 <sup>th</sup> April 2021
<b>Deadline for appellant to submit additional evidence</b>	27 <sup>th</sup> April 2021
<b>Late applications for appeals will be heard by</b>	At the same time as previously scheduled appeals if possible or as soon as is reasonably practicable if not
<b>Decision letters sent to appellant</b>	Normally within seven calendar days

<b>Appeals for Sixth Form</b> – appeals may be made by the student and/or the parent/carer	
<i>Please note that current government legislation requires all appeals up to 30<sup>th</sup> September 2021 to be heard by video conferencing.</i>	
<b>Deadline for lodging appeals and providing evidence to support the appeal (if appropriate)</b>	9 <sup>th</sup> September 2021
<b>Appeals will be heard by</b>	7 <sup>th</sup> October 2021
<b>Notice of appeal hearing</b>	23 <sup>rd</sup> September 2021
<b>Deadline for governing body to submit evidence for the appeal</b>	23 <sup>rd</sup> September 2021
<b>Deadline for sending appeal papers to all parties</b>	23 <sup>rd</sup> September

<b>Deadline for appellant to submit additional evidence</b>	1 <sup>st</sup> October
<b>Late applications for appeals will be heard by</b>	At the same time as previously scheduled appeals if possible or as soon as is reasonably practicable if not.
<b>Decision letters sent to appellant</b>	Normally within seven calendar days

<b>Appeals for in-year admissions</b>	
<i>Please note that current government legislation requires all appeals up to 30<sup>th</sup> September 2021 to be heard by video conferencing.</i>	
<b>Deadline for lodging appeals and providing evidence to support the appeal (if appropriate)</b>	28 calendar days from the date of notification that the application was unsuccessful
<b>Appeals will be heard</b>	As soon as is reasonably practicable
<b>Notice of appeal hearing</b>	At least 14 calendar days' notice
<b>Deadline for governing body to submit evidence for the appeal</b>	14 calendar days before the appeal hearing
<b>Deadline for sending appeal papers to all parties</b>	No later than 14 calendar days before the appeal hearing
<b>Deadline for appellant to submit additional evidence</b>	Seven calendar days before the appeal hearing. Information or evidence not submitted by the deadline might not be considered at the appeal
<b>Late applications for appeals will be heard</b>	As soon as reasonably practicable.
<b>Decision letters sent to appellant</b>	Normally within seven school days
